**Call for the selection of n. 1 Junior Researcher**

The University of Pisa announces a call for 1 junior full-time researcher for (Annex A)

Disciplinary Scientific Sector: **MED/07 - MICROBIOLOGY AND CLINICAL MICROBIOLOGY**

The fixed-term contract is for researching and teaching, integrative teaching activities and services for students, for a 350 hours commitment, on a full-time basis.

The junior Researcher has to perform lectures for 60 hours, with a 10% variability, for each academic year, allocated as an institutional assignment for Bachelor's and Master's degree programmes, Specialization Schools and PhD programmes. In order to avoid an excessive partitioning of teaching modules, an exception up to 72 hours could be allowed.

Contract duration: 3 years

Gross annual salary: € 34.898,06

**Selection procedure:**

The Committee will be appointed by a Rector's Decree and will be composed of three members.

The selection will be made according to a preliminary assessment of the candidates with an accurate and evidenced analytic evaluation of the Curriculum of qualifications, and of scientific results, including PhD thesis.

After the preliminary assessment, will be admitted to a public interview the candidates comparatively most meritorious, representing between 10 and -20 % of the total and not less than 6 candidates. The interview will concern applicant's qualifications and scientific results. In the event the number of applicants is six or less, all candidates are admitted. All candidates will be summoned by registered post at least twenty days before the interview; the failed attendance to the interview will be considered as a voluntary renunciation.

During the interview, all candidates will be also tested also on the foreign language skill requested by the selection.

The candidates living abroad and therefore unable to attend the interview at the University of Pisa, will be allowed to be interviewed via the web or via a conference call, prior applicant's identification by approved international universities or research centres and upon Committee approval.

The committee is appointed to establish the duly t examination of the candidates and shall acquire each candidate's copy of an identity card or passport.
